Sheriff Review: Deputy Justice gave report

**First Item of Business:** Dave presented the well house bids. Gary Jones came in at 765,516.95 and Streamline came in at 689,668.46 The council reviewed the numbers from the spread sheet that Dave provided. The city would be responsible for 27,000.00 after using the rest of the grant money. The council decided to award Streamline Precision the contract. Al moved to award streamline the contract, Brett seconded the motion and the vote was unanimous.

**Second Item of Business:** the residents on 1900 S. are becoming upset about the truck traffic on their road from the gravel pits. The road is being dusted out and destroyed. The city cannot do anything to change this, because the gravel pits and the companies that pull from them are allowed by the county, so the county must hold these companies accountable. First step, city council must meet with a county commissioner and get them to come and see the issue. Al to reach out and set up that appointment. We will follow up in the next meeting.

**Third Item of Business:** Museum wants to put the city building on the home tour. The council agrees to add it to the tour. Council member must be available to host the tour, Buffy may be here for the tour.

**Fourth Item of Business:** Vigilantes have hired a sponsor for the pioneer day celebration, and they want to put them in the parade. The council says that will be fine, but they must be after the veterans and honored pioneers.

**Fifth Item of Business:** Brett and Tyann walked through the old city office building. The council wants to move forward with renovations and then see who may be interested in renting it. Jared and AJ to begin renovations as time allows, probably in the winter when things slow down.
